CRI created, and continues to develop, an intervention methodology based on initiating, growing and nurturing mutually enhancing relationships delivered through activities in three strategic platform areas: 1) Renewal team aligns caring people communitywide, 2) Haven House connects friendship one block at a time to place caring in the system, and 3) Friendship House restores hope in neighborhoods of concentrated disadvantaged.
